

## **East London Bazaar Co – Stallholder Terms and Conditions**

These Terms and Conditions apply to all stallholders participating in events organised by East London Bazaar Co. By booking a stall and/or signing this document, you confirm your agreement to the following terms:

### **1. Stall Booking and Payments**

- 1.1. All stall bookings must be paid for in full in advance to secure your space.
- 1.2. No refunds will be issued under any circumstances once payment has been made.
- 1.3. You may not transfer, substitute, or share your stall space with another trader or individual without prior written consent from the organiser. Any replacement must be like-for-like and approved in advance.
- 1.4. Sub-letting your space for a higher price than originally paid is strictly prohibited.
- 1.5. Stallholders must sign this agreement prior to attending the event. No unsigned participants will be allowed to trade.

### **2. Set-Up and Attendance**

- 2.1. You must arrive at the venue within the allocated set-up time. Late arrivals may result in forfeiture of your space without refund.
- 2.2. You are responsible for bringing your own equipment, table setup, and displays unless otherwise stated in writing by the organiser.
- 2.3. You must not swap pitch positions or encroach beyond your assigned boundary. Keep all goods and displays within your booked area.

### **3. Behaviour and Conduct**

- 3.1. Verbal abuse, aggressive behaviour, threats, or harassment towards organisers, staff, volunteers, or fellow stallholders will not be tolerated and will result in immediate removal without refund.
- 3.2. Any complaints must be raised professionally and respectfully.
- 3.3. Badmouthing the event or organizer, whether online, on social media, or to third parties, will result in refusal of future bookings.
- 3.4. Loud music, aggressive sales tactics, and other disruptive behaviours are not permitted without prior written permission.
- 3.5. Stallholders must keep their space clean and leave it in the same condition as found. Any damage to the venue will be the stallholder's responsibility.

### **4. Weather and Footfall**

- 4.1. Weather conditions on the day of the event are beyond our control and are, as we say, "up to Allah."
- 4.2. We do not guarantee footfall, sales, or customer engagement on the day of the event.

### **5. Cancellation by Organiser**

- 5.1. East London Bazaar Co reserves the right to cancel the event at any time and without prior notice.
- 5.2. If the event is cancelled due to a venue change and you are unable to attend the new

venue, you will be given the option to either carry your booking over to a future event or receive a full refund.

5.3. We reserve the right to refuse stall bookings at our discretion, without the need to give a reason.

## **6. Responsibility and Liability**

6.1. Stallholders are responsible for their own goods, cash handling, and any setup used during the event.

6.2. East London Bazaar Co accepts no liability for any loss, theft, damage, or injury sustained during the event.

## **7. Photography and Filming**

7.1. By signing these Terms and Conditions, unless otherwise stated in writing in advance, you consent to being photographed and/or filmed at East London Bazaar Co events, and for such content to be used and published by us.

7.2. East London Bazaar Co has an in-house media team that may capture photos and video footage throughout the event. In addition, members of the public attending the event may also take photos or record videos, which may be published on social media or other platforms. We cannot control or be held responsible for third-party content.

7.3. All photos and video footage captured by or on behalf of East London Bazaar Co may be used for promotional purposes, including but not limited to our website, social media platforms (such as Instagram), and marketing materials.

7.4. We do not tag individuals in content without prior consent. However, your stall or image may appear in general photos or videos used to showcase the event.

7.5. If you do not wish to appear in any official media, you must notify us in writing before the event. While we will take reasonable steps to respect such requests, we cannot guarantee exclusion from all footage, especially in group or wide-angle shots.
